8 9 0 1 2	WHEREAS, at a public hearing held on, the Village Council, upon second and final reading of this Ordinance, recommended adoption of the EAR-Based Amendments to the Comprehensive Plan in accordance with Sections 163.3184, 163.3187, 163.3189 and 163.3191, Florida Statutes

The Village Council hereby recommends approval and adoption of the Evaluation and Appraisal Report (EAR) Based Amendments, various updates of the Goals, Objectives, and Policies to the Village of Sea Ranch Lakes Comprehensive Plan in accordance with Florida Statutes Chapter 163 as provided and is attached as Exhibit "A".
