Hurricane clean up is a 4 man crew with a tree truck and chipper at \$350 per hour.

9 hour day is \$3,150 per day. Stump grinding at \$125 per hour for labor/truck/stump grinder.

Dump fees are \$12 per yard.

*In the event of a hurricane, The Tree Team Inc. will place Village of Sea Ranch Lakes on a first call list.

The Tree Team will be working once the storm has passed and travel conditions are safe.

Our first response will be to clear fallen trees from roadway and buildings.

The Tree Team is pre-approved by Village of Sea Ranch Lakes to commence clean up work valued at \$10,000. Beyond that amount, The Tree Team and Village of Sea Ranch Lakes will agree on further amounts and direction of clean up. Both The Tree Team and Village of Sea Ranch Lakes will provide each other with contact numbers.

Additional men for tree work will be \$87 per man, per hour.
