A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF SEA RANCH LAKES, FLORIDA, APPROVING, AUTHORIZING, AND ESTABLISHING AN ADMINISTRATIVE FEE FOR COSTS ASSOCIATED WITH CODE VIOLATION CASES BEFORE THE SPECIAL MAGISTRATE AS AUTHORIZED UNDER SECTION 9.06.10(J) OF THE VILLAGE'S CODE OF ORDINANCES ENTITLED "COST RECOVERY"; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village Council of the Village of Sea Ranch Lakes, Florida deems it to be in the best interests of the Village to approve, authorize, and establish an administrative fee for costs associated with code violations before the special magistrate as authorized under Section 9.06.10(J) of Village's Code of Ordinances; and

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF SEA RANCH LAKES, FLORIDA THAT:

SECTION 1. The foregoing "WHEREAS" clause is true and correct and hereby ratified and confirmed by the Village Council. All exhibits attached hereto are hereby incorporated herein.

SECTION 2. The Village Council of the Village of Sea Ranch Lakes, Florida, hereby approves, authorizes, and establishes an administrative fee for costs associated with code violations before the special magistrate in the amount of \$_____.00 for each case as authorized under Section 9.06.10(J) of Village's Code of Ordinances entitled "Cost Recovery" to cover the costs associated with code violation cases before the Special Magistrate.

SECTION 3. If any clause, section or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered as eliminated and in no way effecting the validity of the other provisions of this Resolution.

SECTION 4. All Resolutions or parts of Resolutions in conflict herewith, be and the same are repealed to the extent of such conflict.

SECTION 5. This Resolution shall become effective immediately upon its passage and adoption.
