13 WHEREAS, the Village Council deems it to be in the best interests of
14 the Village to approve and authorize the proper Village officials to execute
15 the 2022 Amendment to Interlocal Agreement Providing for Division and
16 Distribution of the Proceeds from the Broward County Additional Three-
17 Cent Local Option Gas Tax On Motor Fuel.

19 **NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF**
20 **THE VILLAGE OF SEA RANCH LAKES, FLORIDA THAT:**

22 **SECTION 1.** The foregoing "WHEREAS" clause is true and correct and
23 hereby ratified and confirmed by the Village Council. All exhibits attached hereto
24 are hereby incorporated herein.

26 **SECTION 2.** The Village Council of the Village of Sea Ranch Lakes, Florida,
27 hereby approves and authorizes the proper Village officials to execute the 2022
28 Amendment to Interlocal Agreement Providing for Division and Distribution of
29 the Proceeds from the Broward County Additional Three-Cent Local Option Gas
30 Tax On Motor Fuel; A copy of the Amendment is attached as Exhibit A hereto.

32 **SECTION 3.** If any clause, section or other part of this Resolution shall be
33 held by any court of competent jurisdiction to be unconstitutional or invalid, such
34 unconstitutional or invalid part shall be considered as eliminated and in no way
35 effecting the validity of the other provisions of this Resolution.

37 **SECTION 4.** All Resolutions or parts of Resolutions in conflict herewith,
38 be and the same are repealed to the extent of such conflict.

40 **SECTION 5.** This Resolution shall become effective immediately upon its
41 passage and adoption.
