3 AN ORDINANCE OF THE VILLAGE OF SEA RANCH LAKES, FLORIDA;
4 AMENDING THE VILLAGE'S CODE OF ORDINANCES BY SPECIFICALLY
5 AMENDING SECTION 2-1 ENTITLED "DUTIES OF MAYOR" TO PROVIDE
6 AUTHORIZATION FOR MONETARY EXPENDITURES FOR THE MAYOR AND
7 VILLAGE COUNCIL, AND TO PROVIDE FOR MONETARY FLOOR FOR
8 ISSUANCE OF REQUEST FOR PROPOSAL OR QUALIFICATIONS; PROVIDING
9 FOR CODIFICATION OF THE ORDINANCE; PROVIDING FOR THE REPEAL OF
10 ALL CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY AND
11 PROVIDING AN EFFECTIVE DATE.

13 WHEREAS, the Village Council of the Village of Sea Ranch Lakes, Florida hereby finds
14 and declares that the adoption of this ordinance is appropriate, and in the public interest of this
15 community.

17 NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE
18 OF SEA RANCH LAKES, FLORIDA:

20 **Section 1.** Each "WHEREAS" clause set forth above is true and correct and herein
21 incorporated by this reference.
22

23 **Section 2.** The Village of Sea Ranch Lakes, Florida hereby amends Section 2-1 of the
24 Village's Code of Ordinances entitled "Duties of Mayor" as follows:

25 The village council does hereby delegate to the mayor the specific powers and
26 duties identified herein and all other powers of the village not otherwise delegated
27 herewith shall remain vested and be exercised by the village council. The mayor
28 shall have the following powers and duties:

29 (1)He/she shall appoint and, when he/she deems it necessary for the good of the
30 village, suspend or remove any or all village employees and appointive
31 administrative officers provided for, by and under the Charter, except as to the
32 village clerk and the village attorney.

33 (2)Direct and supervise the administration of all departments, offices and agencies
34 of the village, except as otherwise provided by the Charter or by law.

35 (3)Attend all council meetings and shall have the right to take part in the discussion,
36 but shall not vote.

37 (4)See that all laws, provisions of the Charter and acts of the village council are
38 faithfully executed.

39 (5)Shall be authorized to expend funds and execute a contract in an amount not to
40 exceed up to ~~\$15,000.00~~ 5,000.00. Any expenditure of funds and the execution of
41 contract exceeding ~~\$15,000.00~~ 5,000.00 but less than ~~\$35,000.00~~ 15,000.00 shall
42 require prior village council approval. Expenditures in an amount that exceeds
43 ~~\$35,000.00~~ 15,000.00 shall require the request for proposals or request for
44 qualifications be issued

45 **Section 3.** If any clause, section or other part of this Ordinance shall be held by any court of
46 competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part
47 shall be construed as eliminated and shall in no way affect the validity of the remaining portions
48 of this Ordinance.

50 **Section 4.** All Ordinances or parts of Ordinances in conflict herewith are hereby repealed
51 to the extent of such conflict.
