12 13 14 15 16	WHEREAS , the Village Council of the Village of Sea Ranch Lakes, Florida hereby finds and declares that the adoption of this ordinance is appropriate, and in the public interest of this community.
17 18 19	NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF SEA RANCH LAKES, FLORIDA:
20 21 22	Section 1. Each "WHEREAS" clause set forth above is true and correct and herein incorporated by this reference.
23 24	<u>Section 2.</u> The Village of Sea Ranch Lakes, Florida hereby amends Section 2-1 of the Village's Code of Ordinances entitled "Duties of Mayor" as follows:
25 26 27 28	The village council does hereby delegate to the mayor the specific powers and duties identified herein and all other powers of the village not otherwise delegated herewith shall remain vested and be exercised by the village council. The mayor shall have the following powers and duties:
29 30 31 32	(1)He/she shall appoint and, when he/she deems it necessary for the good of the village, suspend or remove any or all village employees and appointive administrative officers provided for, by and under the Charter, except as to the village clerk and the village attorney.
33 34	(2)Direct and supervise the administration of all departments, offices and agencies of the village, except as otherwise provided by the Charter or by law.
35 36	(3) Attend all council meetings and shall have the right to take part in the discussion, but shall not vote.
37 38	(4) See that all laws, provisions of the Charter and acts of the village council are faithfully executed.
39 40 41 42 43 44	(5)Shall be authorized to expend funds and execute a contract in an amount not to exceed up to \$15,000.00 5,000.00. Any expenditure of funds and the execution of contract exceeding \$15,000.00 5,000.00 but less than \$35,000.00 -15,000.00 shall require prior village council approval. Expenditures in an amount that exceeds \$35,000.00 15,000.00 shall require the request for proposals or request for qualifications be issued
45 46 47 48	Section 3. If any clause, section or other part of this Ordinance shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be construed as eliminated and shall in no way affect the validity of the remaining portions of this Ordinance.

Section 4. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed to the extent of such conflict.
