30 31 32 33	Section 3. The final millage adopted herein is greater than the rolled-back rate of 6.5276 mills computed pursuant to the TRIM Act (Section 200.065, Florida Statutes, 2010, as amended) by7.2365%.

If any clause, section or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be construed as eliminated and shall in no way affect the validity of the remaining portions of this Resolution.
