ORDINANCE NO. 2023-04

AN ORDINANCE OF THE VILLAGE OF SEA RANCH LAKES, FLORIDA AMENDING THE VILLAGE CODE OF ORDINANCES BY SPECIFICALLY AMENDING SECTION 4-26 ENTITLED "RUNNING AT LARGE PROHIBITED" TO REQUIRE DOGS TO BE LEASHED WITHIN THE VILLAGE; PROVIDING FOR CODIFICATION OF THE ORDINANCE; PROVIDING FOR THE REPEAL OF ALL CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Village Council of the Village of Sea Ranch Lakes, Florida hereby finds and declares that the adoption of this ordinance is appropriate, and in the public interest of this community.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF SEA RANCH LAKES, FLORIDA:

Section 1. Each "WHEREAS" clause set forth above is true and correct and herein incorporated by this reference.

Section 2. The Village of Sea Ranch Lakes, Florida hereby amends Section 4-26 of the Village's Code of Ordinances as follows:

Sec. 4-26. - Running at large prohibited. Restraint Required.

~~It shall be unlawful for any person who shall own or be in control of or in charge of any dog to permit such dog to run at large within the corporate limits of the village. All dogs within the Village shall be restrained at all times by means of a chain, leash, or other humane means of restraint, unless the dog is upon the owner's enclosed property.~~

Section 3. If any clause, section or other part of this Ordinance shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be construed as eliminated and shall in no way affect the validity of the remaining portions of this Ordinance.

Section 4. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 5. Codification of this Ordinance is hereby directed and authorized.
