32	Section 3. The tentative budget shall be published in accordance with the			
33	publication and notice requirements set forth in Chapter 200, Florida Statutes. A public hearing			
34	will be held on the 13th day of September, 2023 at 5:01 p.m. for the purposes of adopting a final			
35	budget.

37	Section 4. If any clause, section or other part of this Resolution shall be held by any			
38	court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid			
39	part shall be construed as eliminated and shall in no way affect the validity of the remaining			
40	portions of this Resolution.

42	Section 5. All Resolutions or parts of Resolutions in conflict herewith are hereby			
43	repealed to the extent of such conflict.

45	Section 6. This Resolution shall become effective immediately upon passage.
