4	A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF SEA
5	RANCH LAKES, FLORIDA, ADOPTING A PROPOSED MILLAGE RATE OF
6	FOR THE VILLAGE'S GENERAL OPERATING FUND FOR THE
7	FISCAL YEAR BEGINNING OCTOBER 1, 2024 AND ENDING SEPTEMBER 30,
8	2025; PROVIDING FOR SEVERABILITY, CONFLICTS, AND AN EFFECTIVE
9	DATE.

11	WHEREAS, a tentative budget has been prepared estimating expenditure and
12	revenues of the Village for the ensuing year, with detailed information, including revenues to
13	be derived from sources other than ad valorem levy, and recommendations have been made
14	as to the amount to be appropriated for the ensuing year; and
15	
16	WHEREAS, the Village Council of the Village of Sea Ranch Lakes has conducted a
17	public hearing and has considered recommendations, the suggested tentative budget, and the
18	tentative millage to be levied to carry on the government of the Village for the ensuing year;
19	
20	NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE
21	OF SEA RANCH LAKES, FLORIDA, THAT:
22	
23	Section 1. That the foregoing "WHEREAS" clauses are hereby ratified and confirmed
24	as being true and correct and is hereby made a specific part of this Resolution upon adoption
25	hereof.
26	
27	Section 2. The Village Council hereby adopts a tentative millage rate of for
28	General Fund budget purposes for Fiscal Year 2024-2025 which represents a% increase
29	over the rolled-back rate ofmills.
30	
31	Section 3. The tentative budget shall be published in accordance with the publication
32	and notice requirements set forth in Chapter 200, Florida Statutes. A public hearing will be held
33	on the 11 th day of September, 2024 at 5:01 p.m. for the purposes of adopting a final millage rate.
34	
35	Section 4. If any clause, section or other part of this Resolution shall be held by any
36	court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid
37	part shall be construed as eliminated and shall in no way affect the validity of the remaining
38	portions of this Resolution.
39	
40	Section 5. All Resolutions or parts of Resolutions in conflict herewith are hereby
41	repealed to the extent of such conflict.

44	Section 6. This Resolution shall become effective immediately upon passage.
