12	WHEREAS, the Village Council of the Village of Sea Ranch Lakes, Florida hereby finds			
13	and declares that the adoption of this ordinance is appropriate, and in the public interest of this			
14	community.

16	NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE			
17	OF SEA RANCH LAKES, FLORIDA:

19	<b>Section 1.</b> The "WHEREAS" clause set forth above is true and correct and herein			
20	incorporated by this reference.

22	Section 2. The Village of Sea Ranch Lakes, Florida hereby amends Chapter 2			
23	"Administration" by specifically creating Section 2-4 entitled "Conflict of Interest" of the			
24	Village's Code of Ordinances as follows:

26	(2-4) No officer or employee shall accept any employment relating to the business			
27	or affairs of any person subject to regulation by the Village, which employment is			
28	incompatible or in conflict with his official duties as such officer or employee; be or			
29	become directly or indirectly interested in any contract, work or business, or in the			
30	purchase or sale of any article, the expense, price or consideration of which is paid			
31	or received by the Village; be or become directly or indirectly interested in the			
32	purchase or lease of any real estate or other property belonging to or taken by the			
33	<u>Village; or acquire an interest in any contract with, or work done for the Village, or</u>			
34	in any franchise, right or privilege granted by the Village. No officer or employee			
35	shall be or become financially interested, directly or indirectly, in any activity,			
36	employment or business or professional work or enterprise or have economic			
37	interests which are inconsistent, incompatible or in conflict with his duties,			
38	functions and responsibilities as such officer or employee.

40	<b>Section 3.</b> If any clause, section or other part of this Ordinance shall be held by any court			
41	of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid			
42	part shall be construed as eliminated and shall in no way affect the validity of the remaining			
43	portions of this Ordinance.

45	<b>Section 4.</b> All Ordinances or parts of Ordinances in conflict herewith are hereby repealed			
46	to the extent of such conflict.

48	<b>Section 5.</b> Codification of this Ordinance is hereby directed and authorized.
